Mark Your Calendars for January 8, 2018!

Our Assessment Workshop will be held on Monday, January 8, 2018 in the University Center Ballroom. Non-academic units will meet 8:30 - 11:30 a.m. and academic units will meet 1:00-4:00. Topics for both groups will include information about changes to the SACSCOC Principles of Accreditation and the Fifth-Year Interim Report. In addition, non-academic units will discuss the creation and use of rubrics as assessment tools while academic units will discuss ways to enhance the transparency of course assignments in order to highlight connections between assignments and course or program student learning outcomes. Participants in the afternoon session should bring 1-2 sample assignments from their courses they would be willing to share with others for discussion.

Update from the SACSCOC Annual Meeting

SACSCOC approved the revised *Principles of Accreditation: Foundations for Quality Enhancement* that are effective as of December 5, 2017 (the date of approval by the membership). We will dig into some of the details of these new changes during our January workshop, but here are a few highlights:

➤ Previously, principles were organized into four categories: the Principle of Integrity, Core Requirements, Comprehensive Standards, and Federal Requirements. Revised Principles are organized into fourteen broad topics/categories. For example,

- standards addressing full-time faculty, faculty qualifications, program faculty and coordination, faculty appointment and evaluation, academic freedom, and faculty development all appear in the category labeled "Faculty."
- ➤ Six standards have been eliminated (including institutional effectiveness standards related to outreach and service), while two new standards have been added. In particular, one of the new standards asks institutions to describe their process(es) of educating students regarding ways to manage debt and repay student loans.
- ➤ Many standards have been reworded to simplify the language, clarify expectations, and/or more closely reflect current and emerging concerns within the region and at the federal level.
- ➤ There is still an expectation of a quality enhancement plan (QEP) that will concentrate on student success, but there will be some process changes in relation to the QEP that will allow greater flexibility to institutions in defining and implementing their QEPs.

SACSCOC will be posting the "official" newly-revised *Principles of Accreditation* soon. In the meantime, you can read the revisions (listed as "proposed") on the SACSCOC website here:

The SACSCOC Resource Manual for the Principles of Accreditation is being revised and reorganized for use with the revised Principles of Accreditation. According to Dr. Michael Johnson, who is revising the manual, the new document will feature expanded rationale and notes sections, lists of sample documentation, questions to consider while responding to standards, and cross-references to SACSCOC documents and other related standards within the Principles. The revised Resource Manual should be available on the SACSCOC website in late Spring 2018.
